16/18 Allotments Report

The Clerk reported the gentleman no longer wished to pursue the three year rent free allotment and, as another had become available, he was offered that one instead. There are a further 5 people on the waiting list so the next person will be offered the same three year term if they wish to take up the offer.

The area alongside the Lodge, New Road has been cleared and the invoice submitted. The contractor suggested that more work was needed to finish the area and the mound of earth currently on the site could be used to fill the lagoon and level the whole area. The allotment holder adjacent to the lagoon will be contacted before any further work is carried out.

Whilst on site this Monday, one of the existing allotment holders has asked if it would be possible to amend the agreements so that they started from October and not April. The Clerk had said that this was something that was going to be looked into and the content of the existing agreements would be reviewed.

Following a suggestion from the floor, Cllr Hunter proposed asking Deborah Corbin to put in a request for an allotment.

Imerys have offered to make up the last remaining part of the path linking Stoborough to the Furzebrook Village Hall (a length of about 30m) and renovate the existing path. They have already liaised with the RSPB and both agreed this was the best way forward. The path crosses RSPB land and Imerys have asked for the Parish Council to contact the RSPB and ask them to allow Imerys to carry out the work. Members felt that we needed to have a few more details, e.g. cost and why the Parish Council needed to be involved at all.

The various inspections and surveys required were also discussed. The group will next meet on Tuesday 7th July. Stoborough School – the proposed bridge near the junction of West Lane and Corfe Road, by the school entrance. The farmer has been contacted but has expressed concern about the on-going maintenance of such a bridge. Cllr Macleod suggested this would be an issue for the PTA.
