Update from Cllr Nick Ireland, Leader of Dorset Council

Following last week's announcement of our planned Household Recycling Centre (HRC, or "the tip") booking system, it's fair to say it's sparked a lot of discussion.

I recognise how much residents value the recycling centres. The reality is, Dorset Council is under serious financial pressure, and we've had to make some tough decisions to reduce costs and protect the services people rely on.

Closing recycling centres or cutting opening hours as a way of saving money would hit residents hard. Instead, the booking system helps us save hundreds of thousands of pounds a year — money we can use to keep all our centres open and running well.

This will also mean Dorset Council taxpayers stop footing the bill for rogue traders and people outside of our area. Right now, we pay BCP Council so our residents can use their sites—but BCP residents use ours for free. That's not fair. Under the new system, non-Dorset residents will still be welcome, but they'll help cover the costs too.

We're not introducing access fees for Dorset residents, and we're not limiting how often you can visit. Booking takes just a couple of minutes online, and a phone option is coming soon. If you're not online, you'll still be able to visit and get help from staff on site. No-one will be turned away while the system beds in.

This is about fairness, sustainability, and protecting services. It helps us manage demand, reduce misuse, and improve recycling."

The policy is intended to give a fair, consistent and equitable approach across the Dorset Council area. This would give the council, as Licensing Authority greater control over the licensing of pleasure craft and ensure that all operators and boatmen are subject to the same application, enforcement and licence conditions regardless of where they trade.

We would therefore welcome your feedback on the new draft policy.
