

# <u>MINUTES OF THE ARNE PARISH COUNCIL MEETING</u> <u>HELD ON TUESDAY 27<sup>TH</sup> APRIL 2021</u> <u>This meeting was carried out by video conferencing</u>

Prior to the start of the meeting, the Chairman reminded those present that the meeting was being recorded for the purposes of the minutes. Once the minutes are agreed, the recording will be destroyed.

# Public Participation

John Ives, Chairman of the Stoborough Meadow Residents' Association, reported that a party took place on the Hayricks at the weekend. This resulted in a considerable amount of additional parking taking place in Stoborough Meadow. There is not room along this stretch of road for cars to be parked on both sides of the road. Residents were unable to park their cars outside their properties and, should an emergency vehicle have needed access, it would not have been possible. The party highlighted the potential consequences that may come from greater use of the Hayricks following the upgrade proposed. To support the potential increased use of the Hayricks, residents would like to see additional, dedicated parking for the site and this should be given financial priority over the upgrade and could be located on Corfe Road. Furthermore, should the Parish Council become aware of any such parties in the future, the Residents' Association is made aware of it.

Stoborough Primary School – Cllr Cranshaw reported that she is hoping to visit after May 17<sup>th</sup>.

#### 21.210 Reports relating to the Hayricks, Allotments and SANG

<u>Hayricks</u> – Parking – people are parking in the Corfe Road entrance already. The Parish Council needs to consider formal steps regarding parking on the verge and should perhaps act as facilitator for this. Invoices have been received for the first stage of the equipment, together with the repairs to the ground and existing equipment. Dog waste stations were considered for placing at each entrance. They combine a bin and dispenser at a cost of  $\pounds 600$  but an alternative would be just the dispenser attached to a post. Consideration will be given to location of bins and how many. A quote has been received for the planting, but further clarification is required.

Footpath 11 – There are now 90 molehills along the length of the footpath. A quote of £420 has been received for dealing with them.

<u>Allotments</u> – Everything is going well, and all allotments are being well-used. Cllr Cranshaw raised the issue of water barrels being used on the allotments. She asked if it would be possible to have them covered as they tend to encourage mosquitos.

<u>SANG</u> – A resident has raised the issue of overnight camping in the car park and tents being erected in the plantation. A request will be made for a sign to be put up saying there is no overnight parking. This is rapidly becoming a health and safety issue.

#### 9. Correspondence and items for action and resolution

#### 21.216 To consider adopting 'No Mow May' for the village green

Members agreed that the contractor should be approached and asked not to mow the area during May. This will be extended to the outside edge of the Hayricks. The Clerk will contact the contractor accordingly.

21.217 To consider the use of peat and pesticides in the parish

The only pesticides used by the Parish Council is that used by the contractor for weed control alongside the main road. This was raised in the past and it is understood that he contacts certain residents, so they are aware not to walk their dogs in the area for 24 hours after the spray has been administered. The Clerk will speak to the contractor to see what other alternatives he might use rather than spraying.

With regard to use of peat – the Parish Council does not undertake any gardening and does not, therefore, use any peat.

#### 21.218 To consider repairs to the Priory Meadow fence

Cllr Cranshaw reported that the fence between Priory Meadow and the tow path has been pushed over. It was noted that the fence serves no purpose as the animals that were originally intended to graze the meadow were not put in. It has been proposed that WDDT will arrange for the fallen fence to be removed and the area left tidy. Members agreed that this would be the best way forward.

# 21.219 To consider contacting Dorset Council and our Local MP to suggest that, as the CEE Emergency is declared, the legislation and funding is needed to make the changes possible

For the declared emergency to be taken seriously, the legislation and funding needs to be put in place instead of just the good intent. This is a Private Members Bill, initiated by Caroline Lucas. The Government declared a climate emergency and targets are already not being met. Cllr Duckworth will draft the letters for comment by members.
