

MINUTES OF THE ARNE PARISH COUNCIL MEETING HELD ON THURSDAY 21ST FEBRUARY 2019 AT STOBOROUGH VILLAGE HALL COMMENCING 7PM

1. Public Participation

SANG – Cllr Pellegrini reported that the edges to the ditches in the car park are collapsing in parts; the catch to the gate coming out of the car park is broken again; the entrance fencing to the car park is broken and beginning to collapse and the bins are being emptied regularly, although there is a small amount of litter in the car park. The area to the north of the SANG is very wet and one of the boardwalks is currently submerged.

19.186 Highways update – SIDs, traffic surveys

The two traffic surveys are in place – one on the Puddletown Road and one on Corfe Road, opposite Melancholy Lane. The Lengthsman has agreed to train on the use of the SID and he has been put in touch with Highways to arrange a suitably convenient training day.

19.187 Neighbourhood Plan Update

The Steering Group is currently working through the amendments to the Plan following the consultation. The Clerk is sending letters to all those who responded to the consultation and is working on producing the Statement of Community Involvement.

19.188 Arne Moors Project update

A stakeholders meeting took place on the 13th February and was attended by Cllr Cranshaw. The project remains a work in progress. There are a number of issues outstanding; the fresh water modelling and the assessments of flood risk and various ecological factors. It is now likely to be about 2 years before an application will be submitted. The next meeting will be held in May.
