

MINUTES OF THE ARNE PARISH COUNCIL MEETING HELD ON THURSDAY 20TH FEBRUARY 2020 AT STOBOROUGH VILLAGE HALL

Prior to the start of the meeting, the Chairman asked those present if anyone had any intention of filming or recording the meeting. No such intentions were declared.

1. Public Participation

20.150 Bogg Lane Nature Reserve – a request was made for some shingle to be put in the entrance to the site before the cattle grid, as the potholes are now very deep. This will be reported to Mr Pettit-Mills.

Mr Nick Cake – Furzebrook Road –sections of the road have sunk below the level of the gully in front of his property, partly as a result of the severe wet weather conditions experienced recently but compounded by the weight of the lorries. The verge bank is being pushed up and damage is being caused to the underlying structure. There is also a danger of black ice across the width of the road should it freeze. Highways will be contacted to see if there is anything that can be done.

The slip trench from Stoborough Green onto the footpath caused considerable flooding of the footpath during the recent heavy rains. This will be followed up with Highways.

20.162 Arne Moors Project Update

The next stakeholders meeting originally planned for Wednesday 26th February at Wareham Town Hall has been postponed until Wednesday 25th March from 5:30 to 7.30pm. The key purpose of the meeting was to show definitive information on the impacts of the proposed scheme on flood risk local. As detailed design commences, the team have been reviewing the embankment positions in response to local concerns and suggestions – this involved possible re-alignment of the embankment. The flood risk models (intertidal and fluvial) are now being updated and re-run to use these revised embankment positions. Unfortunately, the results will not be ready in time for the original meeting on the 26th February.

There was a meeting held today at the Redcliffe Yacht Club. This was convened to discuss concerns raised by the possible repositioning of the embankment. There is a possibility that a newsletter may be produced in the future to keep residents up to date with events.

10. Correspondence and items for action and resolution

20.166 To consider organising a Climate Change event

Cllr Duckworth felt that, having declared support for Dorset Council's Climate Emergency declaration, we must consider where we go from here. Perhaps holding a public event would be the best way forward. The bigger the catchment, the more successful the event. He suggested contacting Wareham Town Council to see if they would be interested in a joint endeavour as Arne is very much related to Wareham as its commercial and cultural centre. He will contact the Town Clerk in the first instance.

Cllr Love felt that there would be very little an individual could do alone, so they might just do nothing. Cllr Duckworth responded saying that he believed many people, especially the young, were keen to do something and perhaps and organised effort could be more effective. Cllr Patrick reported that her local Church had a speaker who highlighted the need to look at the small things that are achievable.

It was suggested that Plastic Free Purbeck or a representative of Dorset Waste Partnership are invited to speak at the Annual meeting to give ideas of what individuals can do to make a difference.

Cllr Duckworth reminded members that he has sent around the personal carbon footprint calculation for individuals to complete.

20.166 To consider a response to the Dorset Local Plan Engagement event

Cllr Duckworth attended the meeting and felt that most of those who attended did not feel that they could influence the outcome. This is the first stage of the consultation process, beginning with parish councils and moving on to town councils before going out to public consultation.

The terminology around 'local need' came under question – is this the local need as deemed by Dorset Council to meet the Central Government requirements or is it the need that has been highlighted by local communities and housing need surveys. The suggestion is that if the community has a school, shop, and other facilities it could cope with additional housing. Would it be better to look at new villages and towns on green field sites, rather than expanding existing settlements and putting additional pressure on the already overstretched infrastructure. This does not stop parishes suggesting development if it is needed to make the existing facilities viable.

The Clerk will liaise with Cllr Duckworth to produce a response to the event.
