# 1. Public Participation Period

Mr. Alexander advised that he was happy to answer any questions regarding the Natural England proposals. He provided an update on the proposed stakeholders meeting which may be delayed until shortly after March 2022 as the submission of the Planning Application for the Arne Moors Project had been affected by Staffing changes at Dorset Council.

# 2. Declaration of Interests

21.150 There were no declarations of interest declared

## 3. To receive apologies for absence

21.151 Apologies had been received from Cllr M Sims and Dorset Cllr Ryan Holloway.

# 4. To confirm the minutes of the meeting held on the 16<sup>th</sup> December 2021

21.152 A copy of the minutes had been issued to all members prior to the start of the meeting. It was moved and seconded that the Minutes of the Meeting held on the 16<sup>th</sup> December, 2021 be approved as a true and accurate record of the meeting. Agreed unanimously. The Chair signed the minutes in the presence of the meeting.

21.153 There were no matters arising.

## 6. Dorset Councillor's Report

21.154 A copy of Cllr Ezzard's report had been circulated prior to the start of the meeting and was updated by Dorset Councillor Ezzard. She reported on the current position regarding the Budget for Dorset Council which would be set at a future meeting.

She reminded the meeting that the Consultation period for the Modifications to the Purbeck Local Plan would end on the 24<sup>th</sup> January, 2022.

A resident had been in touch regarding traffic speeds near to the school. The Speed Indicator Devices had been sited following consultation with the Parish Council and if it

was felt the sites should be revised then the Parish Council would need to make a formal request to Dorset Council. Alternatively, residents could consider setting up a Speed Watch Group and advice would be available on how this could be achieved.

Cllr. Ezzard outlined the work being done at the roundabout near Wareham Station (Phase 1) which would be followed by Phase 2 and completed next winter including the realignment of the road and widening the footpath at the Saxon roundabout.

A member of the Parish Council also highlighted the problems of animals straying into the road along Furzebrook Road resulting in animal deaths.

The Parish Council's request for the speed limit along Arne Road to be reduced would be considered as part of the planning application to be submitted by the National Trust

# 21.156 To agree the bank reconciliation and position against budget

Copies of the reports had been issued to all members prior to the start of the meeting. The meeting noted the current balances and the Budget Report for the period ended 31<sup>st</sup> December, 2021.

#### 21.157 BUDGET 2022/23

The Clerk had circulated the proposed Budget for 2022/23 which recommended that the Precept should be set at £39540.20. This was the same amount requested for the current Year

It was moved and seconded that the proposed Budget should be increased by £4000 and not taken from Reserves as suggested. This would protect the Council's finances from inflation and also maintain the balances.

However, on being put to the vote the motion was lost 2 votes in favour and 5 against. It was then moved and seconded that the Precept for 2022/23 should be set at £39540.20 and the Budget Report 2022/23 be adopted.

The Council's current reserves were sufficient to support expenditure during the 2022/23 and any contingencies which may arise during the year. Council Taxpayers would be facing other pressures on their household finances and not increasing the Precept would help Parishioners during this period.

The motion was then put to the Vote with 5 members in support and 2 against and it was, therefore: RESOLVED i) That the Budget for 2022/23 as circulated to Members be approved.

ii) That the Precept for the financial year 2022/23 be set at £39540.20 and that the Clerk be authorised to submit the Precept request 2022/23 to Dorset Council.

- Approved payments authorised at APC Meetings to be initialled by the Chair at meetings
- The Responsible Financial Officer to take all steps to pay all invoices submitted which are in order at the next APC Meeting
- Regular payments including Salaries, PAYE/NI to be signed by 2 APC Members on all occasions when payment is made
- Approval of the use of BACS to be renewed by APC at least every two years
- PIN and Passwords of all authorised signatories to be given to the Chair in a sealed and dated envelope
- Bank Mandate to state which payments can be instructed by the Clerk alone when acting as Service Administrator

Members agreed that the current Risk Assessment, Standing Orders and Financial Regulations remained suitable and that the financial procedures listed above together with the Risk Assessment were appropriate and it was, therefore,

RESOLVED: i) That, having reviewed the current procedures including the Risk Assessment, Standing Orders and Financial Regulations these be adopted for continued use and reviewed again in the next Financial Year.

- ii) That the Council confirm the current Banking arrangements with Barclays Bank
- iii) That Mr. Edwin Macknamara be confirmed as the Clerk and Responsible Financial Officer.
- iv) That the authorised Bank signatories be confirmed as Cllrs. Cranshaw, Sims and Patrick together with the current Clerk to the Council/RFO.
