

MINUTES OF THE ARNE PARISH COUNCIL MEETING HELD ON THURSDAY 15TH JULY 2021 AT STOBOROUGH VILLAGE HALL, COMMENCING 7PM

1. Public Participation Period

Jane Lambert of the Stoborough Meadow and co-founder of Sustainable Wareham – raised the enhancement of the Hayricks. No Mow May produced a number of interesting flowers. There has also been talk of tree planting on the site and she felt that the area in front of the new fence would be an ideal site for planting wildflowers and trees. She would be happy to co-lead a walk around the Hayricks telling people what is there and how the bio-diversity of the site will work and encourage pollinators.

Joy Gwinnett expressed concern about crossing the bypass from Grange Road. The bypass acts as a barrier to people living in Grange Road who wish to walk or cycle to Stoborough. She would like to request that a crossing is installed to facilitate this.

Catherine Farrugia reported that there will be a public presentation of the Arne Moors Project later in the year. The planning application is now due to go in after Christmas. The presentation that was given at the Stakeholders meeting on the 14th July will be available on the website and members of the public are invited to send in any questions they may have. Funding is currently in place to take the project to the planning application stage. Once planning is submitted, additional funding will be requested.

Planting – An email had been sent to all members regarding a planting proposal. This will involve planting 4 or 5 trees in the central area but not encroaching on the football area. This will include a memorial tree, shown on the plan as 'tree with circular bench'. About 60 shrubs will be planted around the site, largely all of which will be native species.

Cllr Sims proposed using Bonsai for the main plan, Anvil for the wildflower sections, subject to costings, and adopt the Trees for Dorset proposal for the hedge/boundary planting.

Cllr Patrick proposed that Cllr Sims suggestion is accepted. This was seconded by Cllr Duckworth and agreed unanimously.

<u>Allotments</u> – Cllr Duckworth reported that 2 of the allotment holders have recently retired. Both allotments were subsequently re-rented. Wessex Water attended the site to clear the overflowing sewage pipe after the period of heavy rainfall. The Scott Estate will be approached to see if they would be willing to donate the neighbouring area, currently not being used, as additional land for allotments.

21.41 <u>To consider supporting Church Knowle Parish Council in requesting a 40mph speed limit throughout Purbeck</u>

An email had been received from Church Knowle Parish Council to canvass opinion on a 40mph. To date, the three Parish Councils that have responded – Kimmeridge, Worth Matravers and East Holme have all rejected the idea as most have organised their own form of traffic calming or do not perceive there to be a problem.

All members felt that this could not be supported. The Clerk will respond accordingly.

Cllr Duckworth pointed out that, following the heavy rain over the weekend, several of the gardens of properties in New Road were flooded. This was partially caused by the run-off from the Lookout and partly by the fact that the water could not get away into the ditches along New Road. One of the issues seems to be the ditch running between the two fields, belonging to the Scott Estate which has not been cleared for many years. They will be approached once again to ask if they would clear the ditch.

Cllr Bessant highlighted the problem of flooding on West Lane by the bypass. Instead of clearing quite quickly, it took two days to clear. Cllr Ward will submit a report to Highways with a list of the drains that need clearing.
