

MINUTES OF THE ARNE PARISH COUNCIL MEETING HELD ON THURSDAY 20TH JUNE 2019 AT STOBOROUGH VILLAGE HALL

Prior to the start of the meeting, the Chairman welcomed Ian Duckworth to the Parish Council.

1. Public Participation

20.27 John Constable, Puddletown Road asked what benefit the Worgret residents receive from the Parish Council as they seem to do everything they need themselves. In addition, he expressed concern regarding the volume of traffic on the Puddletown Road, saying there must now be about 200 lorry movements per day. Lorries are turning left into Puddletown Road. The skip lorries are supposed to operate from 7am to 5pm – this was addressed some time ago, but the times have been stretched again. The Clerk will check the recent traffic survey and inform Mr Constable of the outcome. With regard to the lorries, this will be passed to the Dorset Councillors to look into, together with the footpath from the Wareham roundabout up to Worgret. The Highways officer will also be asked to look into this. It was noted that there is still a vacancy on the Parish Council and the residents of Worgret might like to think about putting someone forward as a councillor to represent their views.

Furzebrook road sign has been mended.

Ian Alexander – nothing to report. Still waiting for the flood risk modelling to come back.
