

MINUTES OF THE ARNE PARISH COUNCIL MEETING HELD ON THURSDAY 18th NOVEMBER 2021 AT STOBOROUGH VILLAGE HALL, COMMENCING 7PM

1. Public Participation Period

Mr Ricks asked for a follow up regarding the flooding of the Moors and the two different models that are being used. This was outlined in the October minutes. This was put to Mr Alexander, who responded saying that the Environment Agency, at the request of the owners of Ridge Wharf and Ridge Farm, agreed that they would undertake an independent examination of the existing EA model. The second model reported and suggested that the original model had underestimated the amount of water that may come down Furze Brook. The EA felt this made no effective difference as it did not affect the chance of Ridge being flooded. The EA are in the process of putting together a response which will be passed to the owners of Ridge Wharf and Ridge Farm as they commissioned the second model. Should there be a significant difference in the findings, the owners of the report will, no doubt, put this to the Planning Authority.

There is an agency that has put together a report showing the amended flood risk from sea water along the whole of the south coast. Ian Alexander felt this was irrespective of the Arne Moors Project as this refers to the Climate Change Emergency situation.

Hartland Moor speed restriction – Ian Alexander has spoken to Dorset Council regarding the grazing unit project. The cattle grids have been installed and will be utilised from next spring. The advice now is that an application for a lower speed limit should be submitted by the Parish Council, supported by the Dorset Councillors and this will then trigger the review of the speed limit. It does not look as though this project is going to come out as a particularly high priority as it is a low-risk route. However, if the application is made now, it means it will be in the system. There are other factors that could be taken into account and Ian is happy to assist the Parish Council with the submission. It would now be appropriate for the Parish Council to pass a resolution to this effect, and he would be happy to help with the wording of the resolution. This will be an agenda item for the New Year.

Cllr Ezzard reported that the charging points in Stretch Road would not be installed as the car park belongs to the Rempstone Estate and not Dorset Council. Bonnets Lane, St John's Hill and Howards Lane car parks will be receiving the electric charging points.

There is a consultation underway covering the new rules to tackle anti-social behaviour.

The Purbeck Local Plan will be going out for the last consultation at the end of November.

Speed limits – Cllr Ezzard will support the reduction in speed limits on Hartland Moor. She suggested that we go for 30mph and we may get 40mph as in the New Forest. It may be necessary to collect some data regarding vehicular and pedestrian use of the area. This may help with the submission.

This is a very small plot and neighbours originally accepted a bungalow could go on the plot. What is now happening is the proposal is being enlarged, with multiple windows, one of which overlooks the neighbours. There is a large tree which takes up a sizeable amount of the plot. The window in question faces number 16 Old Furzebrook Road. Which side is 'the rear' of the property?

Object – There is a lack of clarity as to which side of the building is elevation 5 and the proposal in general. There is a possibility of the proposed window and balcony reducing the privacy of the adjoining property.

21.120 To consider the future management of the Hayricks

The contractor has yet to respond to the report and has not costed it. One of the items covers how the grass areas on the perimeter should be managed. A path has been included along the hedge line which would be kept cut during the growing season to allow access to the area

The grass along the eastern boundary, together with that on Footpath 11 have been quite badly damaged by the tractor cutting the hedges. Cllr Duckworth is exploring sources of wildflower seed for Anvil.

It was noted that the oak trees on the Havricks had also been flailed on the eastern boundary as the hedges were done. In future, the contractor will be asked not to flail the hedges. This will be brought out in the redrafted contract.

A letter will be sent to the contractor expressing our disappointment.

This will be brought forward to the next meeting.
