

MINUTES OF THE ARNE PARISH COUNCIL MEETING HELD ON THURSDAY 16TH SEPTEMBER 2021 AT STOBOROUGH VILLAGE HALL, COMMENCING 7PM

1. Public Participation Period

Wareham bypass – A resident asked if there was anything that could be done to lower the speed limit. Pedestrians do not feel safe crossing at the roundabout by the Blue Pool. It was suggested that any concerns should be put to Dorset Highways with a copy to the Ward Councillors. It was noted that the bypass was put in place in order for vehicles to avoid the village roads and it is split at reasonable points to allow safe crossing. It may be possible to ask the Police to monitor the stretch leading up to the roundabout where it is felt vehicles are travelling in excess of the speed limit.

Ian Alexander reported that the work on the cattle grids on Hartland Moor would be commencing and he would forward a map of the location of the grids. The fencing exercise will happen over the coming winter, and Natural England are in discussion with the owners of the livestock regarding what and how many can be put on the land. The next step will be to discuss the speed limit within the grazing unit. Once the grids are installed, it would be an appropriate time to start talking about the speed limit. He suggested that the Parish Council might like to start thinking about speed limits within the area as any amendments to the current limit will need to be led by the Parish Council.

5. Matters arising – for report only

21.68 SANG sign – Mr Pettit-Mills had confirmed that the Estate would be looking to install a new sign which would include the logos of Dorset Council and the Police. This may discourage the removal or damaging of the sign in the future. He is currently liaising with Dorset Council regarding this.

Ragwort – Whilst it is the responsibility of farmers to clear ragwort, it is not compulsory for all landowners to do so. Ragwort is only harmful to livestock if it is cut, dried and baled. In normal circumstances, livestock do not eat it and it is a natural resource for flies and other insects.

21.69 A copy of Cllr Ezzard's report had been issued to all members prior to the start of the meeting. No comments were made.

Regarding the speed limit over Hartland Moor, Cllr Ezzard felt she would like to see a 40mph limit, as in the New Forest.

Cllr Church noted that signs highlighting the fact that there are animals roaming the area should be put in place as soon as possible.

<u>Hayricks</u> – Cllr Cranshaw reported that Cllr Duckworth has been in touch with the Chair of Trees for Dorset. They are able to support 50% of the cost of the planned planting. We already have 2 days allocated for planting – they are Friday 12th November for the school involvement and Saturday 13th November for community involvement. A 10am start is proposed with a break for lunch. It is proposed that no large trees will be planted in order to maintain the present proportion within the Hayricks. No oak, hornbeam or field maple will be planted.

Anvil will deal with the grass encroaching on the footpath in the Hayricks. At the end of the season, they will be trimming the boundary hedgerow with the aid of a tractor.

The Parish Council must consider the rewilding experiment from the last year, especially with regard to the village green which should retain its amenity value. Cllr Cranshaw suggested a sub-committee is set up to look at the plans for the Winter and the costs and choices for the Spring.

Benches – to be raised and repainted, possibly with the assistance of the Men's Shed who will also undertake some painting in the play area.

<u>Allotments</u> – All the allotments are in full use and the contracts for the coming year are due to be issued shortly.

SANG – Nothing further to add.
